Internet/ Direct Banking

If you have internet or telephone banking, you can use the details in the standing order form to instruct your bank directly.

Gift Aid

If you pay Income Tax and/or Capital Gains Tax you can make your donation go further. Complete and sign the Gift Aid Declaration and we can claim 28p for every £1 you donate, at no cost to you.

You can cancel your Declaration at any time by notifying the Planned Giving Recorder.

If in the future your circumstances change and you no longer pay sufficient tax, or you change your name and address please notify the Planned Giving Recorder.

Remember that if you pay tax at the higher rate you can claim further tax relief from HMRC.

Data Protection and Confidentiality

The Parish Recorder is responsible for keeping all information regarding Planned Giving. It is held within the Parish and will not be divulged to any outside organisations.
